SHIFTING/CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Radhakrishna College of Education, Srikakulam District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed./196/SRO/NCTE/2002-2003/6153 dt. 26.03.2003 for B.Ed. course of one year from the academic session 2002-2003 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 11.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the institution has requested for reduction of intake from 2 basic units to 1 basic unit on 31.08.2016. The SRC in its 342nd Meeting held on 05th & 06th July, 2017 considered the matter and decided to reduction of units as per request of the institution. Accordingly, as per the decision of SRC an order vide dt. 21.07.2017 was issued by the SRC for reduction of intake from 2 units to 1 unit.

4. **AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and the Committee decided that Show Cause Notice to be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 01.03.2019. The institution has submitted its reply on 18.03.2019.

5. **AND WHEREAS**, the SRC in its 381st Meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 29.12.2019. The institution has submitted its reply on 26.02.2020.

6. **AND WHEREAS**, the matter was further considered by the SRC in its 392nd Meeting held on 15th & 16th December, 2020 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC withdrawal order vide order no. F.SRO/NCTE/APSO0233/B.Ed./{AP}/2020/122099-2105 dt. 29.12.2020 was issued to the institution.

7. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. File no. 89-241/E-276332/2022 Appeal/8th Meeting, 2022 APPLSRC202113929 dt. 16.11.2022 and the Council remands back the case. The Committee has decided since the Withdrawal order has been set aside by the appellate Committee, the SRC will issue restoration order to the institution.

9. **AND WHEREAS**, the institution has filed writ petition bearing no. WP (C) 17653/2022 titled as Sri Radhakrishna College of Education VS NCTE & OTHERS before the Hon'ble High Court of Delhi at New Delhi. The Hon'ble High Court vide order dt. 23.12.2022 directed as under: -

"1. In view of the above, the petition is allowed. Respondents are directed to issue a restoration order in terms of directions of the Appellate Authority within a period of 10 days from today. Respondents are also directed to display the name of Petitioner-College in the list/ category of recognised institutions for conducting B.Ed. course on their website. The same shall also be communicated to the affiliating university as well as the Department of Higher Education, Government of Andhra Pradesh to enable Petitioner College to participate in counselling and admission process for academic year 2022-23 and for subsequent years, unless a withdrawal order is passed subsequent to this order.

2. The petition is disposed of, along with all other pending application(s)."

10. **AND WHEREAS**, the order dt. 23.12.2022 passed by the Hon'ble High Court of Delhi and order dt. 16.11.2022 passed by the Appellate Authority, the status of Sri Radhakrishna College of Education, Palakonda, Vaddadivari Street, Srikakulam, Andhra Pradesh - 532440 for B.Ed. programme for (one basic unit) of 50 students in recognized institution and is entitled to the benefits of recognition unless and until fresh withdrawal order is passed.

11. **AND WHEREAS**, the SRC in its 419th meeting held on 13th January, 2023 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 17.02.2023. The institution has submitted reply on 07.08.2023.

12. **AND WHEREAS**, the SRC in its 428th meeting held on 25th August, 2023 considered the matter and decided to constitute online VT for shifting premises. The online inspection conducted on 30.11.2023 and VT report received on 30.11.2023.

13. **AND WHEREAS**, the SRC in its 430th meeting held on 1st December, 2023 considered the VT report decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 11.12.2023. The institution has submitted reply on 26.12.2023.

14. **AND WHEREAS**, the SRC in its 431st meeting held on 10th January, 2024 considered the matter and decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on perusal of the reply submitted by the institution namely Sri Radhakrishna College of Education decided that shifting of premises be permitted to

- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

19. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

20. The institution shall make available the list of students admitted on its official website.


21. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

the institution at new address i.e. **D.No. 14-1162, Sai Nagar Colony, Palakonda, New Yalam Jn, Palakonda, Panchayat, Srikakulam District, Andhra Pradesh-532440.** The Committee also decided that **continuation order** be issued to the Institution for **B.Ed. programme for 1 basic unit of 50 students.**

15. NOW THEREFORE, this order is issued permitting the institution i.e. **Sri Radhakrishna College of Education, Palakonda, Vaddadivari Street, Srikakulam, Andhra Pradesh – 532440 to shift its building at new address at D.No. 14-1162, Sai Nagar Colony, Palakonda, New Yalam Jn, Palakonda, Panchayat, Srikakulam District, Andhra Pradesh-532440.** Further as per the decision of the SRC, an order for continuation of recognition for B.Ed course of two years duration with an intake of (one unit) of 50 students subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

16. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.


17. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

18. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
